

GUIDE TO ENROLLMENT



“Get Behind the Badge” Volunteers always have been, and always will be, the backbone of the United States Bowling Congress. They are dedicated, hard-working, unselfish people who have the sport’s best interests at heart.

It is extremely important in today’s world that all volunteers who work with USBC Youth programs understand that USBC is facing the same problem every youth sports and social organization in America is facing: protecting our youth against a handful of people who prey on the innocence of children.

Child abuse, sexual misconduct and domestic violence are insidious crimes committed by people who often look and act “normal”. The only practical way to make youth bowling safe is to identify those who refuse to abide by acceptable standards of behavior and conduct, remove them from contact with our young people and establish barriers to prevent other predators from gaining access to children who bowl.

To protect our youth, the USBC has created a Registered Volunteer Program to assure parents that bowling is doing everything it can to provide a safe haven for youth. As a leader in the world of youth sports, USBC has created a model we hope all other youth sports organizations will equal or exceed.

Your participation in USBC’s Registered Volunteer Program is extremely important in helping our sport create a safe haven for young people.

If you decline participation, you will automatically disqualify yourself as a USBC Youth volunteer. In the event you may reconsider in the future, you may complete the enrollment process on-line at bowl.com.

Background Screening Basics The background screening process, explained in the USBC Registered Volunteer Rules and Policies, is intended to identify and remove those who have a history of behavior that might pose a threat to young people. It does not involve personal credit checks or motor vehicle violations.

A background screen that produces a “green light” means no disqualifying criminal record has been found and the individual will be approved as a USBC Registered Volunteer.

If the background screen produces a “red light,” the volunteer will be contacted directly by NCSI. If information is missing or inaccurate, a re-screen will be done. A final “red light” determination, which disqualifies a volunteer from working with USBC Youth, will be issued only after a complete investigation upholds the original findings.

Basic Program Overview To continue working with USBC Youth, the following individuals are required to complete the registration process:

- Anyone 18 years of age or older who has regular physical or verbal contact with USBC Youth bowlers, holds a position of authority or supervision over USBC Youth programs, has an opportunity to establish a position of trust, and/or has an opportunity to build a one-on-one relationship through USBC Youth programs must register as a USBC Registered Volunteer.
- Specific roles or positions within the USBC Youth program that require registration are detailed in the USBC Registered Volunteer Rules and Policies. (I.e. Non-merged Youth Association Board members)

Individuals are “screened” by NSCI, the National Center for Safety Initiatives.

The criteria used for screening is detailed in the USBC Registered Volunteer Rules and Policies.

All volunteers who wish to participate in the RVP will do so online and will pay by credit card (Master Card or Visa).

The cost is \$20 for the screening and administrative fees will be \$1.25.

- There might be additional screening fees if your state or county charges additional fees, or if you submit incorrect or inaccurate information.

The volunteer may be reimbursed if their fees ultimately are handled by their association or proprietor.

Based on the results of the screening, the volunteers will be issued either a “Green Light” or a “Red Light” determination.

- Volunteers with a “Red Light” determination may not work with USBC Youth.
- Volunteers with a “Red Light” determination may appeal the decision to USBC Headquarters.
- USBC will send a USBC lanyard and badge to “Green Light” volunteers.

RVP Badges are good for two years.

Registered Volunteers will be listed on bowl.com.

Volunteers will receive an e-mail notice when it is time to renew their badge.

Additional administrative fees of \$5.00 will be charged by NSCI to volunteers who do not complete the process online and require a paper application.

How to Enroll To enroll as a United States Bowling Congress Registered Volunteer, individuals must complete the registration process through the National Center for Safety Initiatives Web site. However, the process begins at www.BOWL.com.

IMPORTANT Please add BOWL.com and ncsisafe.com to your accepted email domain list to receive notifications from NCSI and USBC.

- Begin at the www.BOWL.com Web site
- Scroll down and click on Registered Volunteers
- Review the information on the RVP Home Page
- Scroll down and click on Forms and Manuals to find the USBC Registered Volunteer Rules and Policies, USBC Registered Volunteer Code of Conduct, USBC Registered Volunteer Frequently Asked Questions and Answers and more.
- Back to the RVP Home Page to click on "Click here to start background check process"

Assuming your background screen produces no record of a criminal background, you will receive a confirmation letter, lanyard and Registered Volunteer identification badge from USBC.

Upon finding a record that may result in a "red light" determination, NCSI will contact you to make certain all information provided is accurate. The information will be investigated to confirm accuracy before a determination is made.

WAIT - You're not done yet!!

It is common for NCSI to have questions or need information from you in the course of the background screening process. You will be contacted via e-mail at the address you provided. Additionally, please log in to our secure online "Applicant Status Check" tool by going to www.ncsisafe.com and clicking on 'Applicant Login' in the left hand menu regularly to check the status of your background screening. You should check this until your status indicates COMPLETED, which means NCSI has issued a determination to your organization. Failure to respond to our requests for additional information may result in a RED LIGHT determination.
