

**1. Age**

Open to all USBC Youth members. Athletes are not required to be entrants in the USBC Junior Gold to enter. This event is certified by the United States Bowling Congress. (CERTIFICATION #5375)

**2. Average Requirements (in order of acceptance)**

- a. Highest 2010-11 USBC league average based on a minimum of 12 games.
  - b. Highest current USBC league average of at least 12 games as of the date of participation. Bowler must present a current standing sheet to verify average.
  - c. Highest USBC 2009-2010 league average based on a minimum of 21 games.
  - d. Bowlers who do not meet any of the above requirements will be entered with a 190 average.
- \* Any bowler who has ONLY A USBC SPORT LEAGUE AVERAGE must utilize the chart which will determine the adjusted average to be used. Chart can be found on bowl.com or in the USBC Playing Rules book.
  - \* Rule 319a-2 and 319a-3 is waived. All averages will be verified and corrected prior to prize payout
  - \* Rule 319e is waived. This rule refers to average adjustment based on tournament average.

**3. Average Verification**

It is the responsibility of the bowler to verify that the submitted average meets tournament rules.

**5. Dress Code**

Entrants are expected to wear suitable attire. Use good judgment when selecting the appropriate attire.

Examples of acceptable attire

- Collared Shirts and Mock-Turtle Necks
- USBC Youth Jersey
- Dress slacks, Skirts and Jeans in good condition
- Shorts with finished bottom (NO FRAYED HEMLINES) that extend to the knee when worn at the waist.  
LENGTH OF SHORTS, SKIRTS, AND SKORTS MUST BE TO THE TOP OF THE KNEE.

Examples of prohibited attire include but are not limited to:

Head gear - (for medical reasons only)

- T-Shirts, tank tops, halter tops, bare midriffs, spaghetti strap tops, etc.
- Workout attire, short shorts, short skirts, bib overalls, jeans that are not neat, clean or in good condition (no torn jeans).

Attire depicting alcohol, tobacco or gambling, an illegal substance or inappropriate language/gestures may not be worn in accordance with Rule 301b.

Bowlers will be required to change if attire is deemed inappropriate by tournament management or designee. Tournament management or designee decision will be final. For questions on appropriate attire, contact the USBC Youth Open tournament office onsite or at USBCyouthopen@bowl.com.

**PRIDE AWARD**

In order to reward teams dressed in a "Team Uniform" USBC has created the "Pride Award." To qualify for the award, all four members of a team must wear matching shirts and pants of the same color when they bowl their team event.

**6. Eating – Smoking – Drinking**

Entrants are NOT permitted to smoke or drink alcoholic beverages while participating in the USBC Youth Open. The center will be a non-smoking venue for all spectators and bowlers. There will be no alcoholic beverages served within the bowling center during the competition. There will be no eating or drinking allowed in the bowlers area during competition.

**7. Equipment**

Each entrant must have a bowling ball for their individual use in the tournament. Only USBC approved bowling balls will be allowed and MUST have the manufacturer's name, product name, and serial number clearly visible at all times for identification purposes. Any scores bowled using a bowling ball that does not meet the above requirements will not count. A maximum of six (6) bowling balls per entrant is permitted in the bowling center at one time. Random bowling ball checking may be done as deemed necessary by tournament management. Bowling balls depicting alcohol, tobacco or gambling may not be used in competition. Tournament staff has the right to remove balls from tournament play that are deemed in violation of the rules.



### 8. Etiquette

Bowlers are not allowed to use electronic equipment of any kind in the bowler's area during competition. This includes but is not limited to cell phones, pagers, video recorders, cameras, radios, palm pilots, headphones, etc. Headphones can only be used on the concourse area and cannot be used while bowling. Unsportsmanlike behavior will not be tolerated on the lanes or inside the bowling center. Individuals are subject to removal for engaging in improper tactics or conduct including, but not limited to, physical and verbal abuse toward other persons.

### 9. Fees

Entry fee for all divisions is \$120-per 4-person team, \$120-per doubles pair (includes singles). All-events fee (optional) is \$5.00 per bowler. Total cost of team, doubles, singles, and all-events for a 4-person entry: \$380.00. Entry fee breakdown for singles, doubles, team event: \$17.00 scholarship fee and \$13.00 expense fee. Scholarship fees will be returned 100%. All-events fee of \$5.00 will be returned 100% in scholarships. **Bowlers MUST enter both the Doubles AND the Singles events.** All-events category must be entered and be paid before the first ball of competition has been thrown by the bowler.

Entries received prior to April 1, 2011 must include full fees or a \$100 deposit (with the remainder of the entry fees due by April 1, 2011). Entries received after April 1, 2011 will be required to submit full fees. Cancellation at any time will be subject to a \$50 cancellation fee. All bowler information is due when full payment is submitted to USBC. Online entries will close July 6, 2011. On-site entries will be accepted as space permits.

### 10. Format

The tournament shall consist of a singles, doubles, and 4-person team in four divisions. Three games will be bowled in each event. There will also be an all-events category in each of the four divisions. **This is a SCRATCH tournament and only actual scores are used.** Bowlers usually will be scheduled to bowl three games in the team event on one day and three games for doubles and three games for singles on another day. **A bowler entering doubles must also enter singles.** Bowlers will be allowed to bowl all entered events the same day if space permits.

Bowlers cannot be listed on an original entry form more than once for any event.

- a. At the tournament site, a bowler will be allowed to bowl one additional time as a substitute in the team event, to fill **unexpected** vacancies. All-events standing will be determined by the bowler's first appearance in the team event.
- b. Entrants may participate in the doubles and singles events only once. Scores bowled by an ineligible player will be disqualified. **A bowler entering doubles must also enter singles.**
- c. Bowlers may enter the team event without bowling singles and doubles.
- d. All-events prizes and scholarships will be awarded separately for males and females within each division based upon number of entries in that gender division.

### 11. Lane Courtesy

One lane courtesy is required and will be enforced.

### 12. Pacers

Pacers shall not be permitted in the tournament.

### 13. Protests, Appeals and Tournament Authority

Any protest or appeal concerning scoring must be made in writing stating briefly the grounds of the protest or appeal and submitted to the USBC Youth Open tournament office no later than 24 hours after the game has been played.

### 14. Refund and Cancellation Policy

No team or individual shall be entitled to a full refund after the entry form and fees have been received and definite dates assigned unless a replacement is requested in writing and the vacated space is filled (See rule #9 for cancellation fee.)

### 15. Scholarships and Awards

Scholarship awards will be distributed: Singles, doubles, team: 1:5 ratio. All-events 1:6 ratio. Scholarships in the singles, doubles and team divisions will be based on total score- no separate divisions for gender. All-Events scholarships will be awarded based on gender within each average division.

Scholarships will be distributed within 30 days after the conclusion of the tournament. All scholarships will be held in SMART (#8571). Recipients will receive notification as to the final placing, as well as to the amount of the scholarship. All results will be posted on bowl.com. In the event of a tie in any event, scholarships will be equally divided. In the event of a tie for first place, co-champions will be declared. All winners' averages are subject to further verification by USBC tournament management. All averages will be verified and corrected.

All first place champions (highest actual total pins bowled) in each division will receive an award.

**16. Special Needs Bowlers**

Bowlers who required special assistance must indicate it on the entry form so that special scheduling consideration can be arranged.

**17. Substitutes**

Substitutes will be allowed in the team event only. A bowler will be allowed to bowl one additional time as a substitute in the team event to fill **unexpected** vacancies. This is an on-site substitution only. A substitute's average may change the division. The substitute will take the place of the original entrant in the line-up and will be entitled to all scholarship awards. A substitute shall be permitted if one is available, for any reason after a game has started only in the team and doubles event. If a substitute is not found, only the actual score of the frames bowled shall count.

**18. Tardy Bowlers**

Teams and/or individual(s) arriving late shall begin play and the scores shall count beginning with the frame then being bowled. Entrant will receive a zero for all frames missed.

**19. Teams Bowling Together**

Teams wishing to bowl together must mark the entry form appropriately and submit them together in one envelope. All other teams are randomly scheduled. USBC does not guarantee doubles/singles events will be scheduled on the same lanes as their teammates. Doubles and singles times are scheduled on a first come basis.

**20. Team Captain**

Each team shall designate an adult who will be the point of contact for the team. Each team will also designate a captain who will be responsible to insure that all team members are advised of the rules of the event.

**22. Other Rules**

The 2010-2011 USBC Playing Rules will be enforced. Tournament games cannot be re-bowled, except as authorized by the tournament management when scores are irretrievably lost in the scoring process. Only competitors and tournament officials shall be allowed in the settee area. Tournament management has the authority to make decisions regarding anything not covered by these rules.

Athletes/Parents/Guardians are responsible for checking with a compliance officer and/or academic counselor at the athlete's school



to ensure compliance with high school and collegiate eligibility rules. Athletes under the age of 18 are under the governance of their parent/guardian for the duration of the event. All athletes shall abide by the rules and conditions for the 2011 USBC Youth Open. Athletes/parents/Guardians release the sponsoring organizations, and each of them, and their respective officers, members, employees, agents, successors and assigns, from any and all liability for any injury to person or damage to or loss of property which an athlete may sustain, or which a parent/guardian may sustain as a result thereof or directly, during or as result of an athlete's participation in the 2011 USBC Youth Open, including any activities incidental thereto and his/her travel to and from the place at which the 2011 USBC Youth Open is conducted.

Consent is given by the athlete and/or parent/guardian to and authorize the sponsoring organizations, and each of them, and their respective officers, members, employees, agents, successors and assigns, and anyone authorized by them to photograph, otherwise record or reproduce, publish and use athlete's name, voice, likeness, and biography and his/her participation and activities in connection with the 2011 USBC Youth Open, alone or with others, hereby releasing and waiving all right, title or interest, which the athlete or parent/guardian have or may have hereafter with respect there to and any compensation or reimbursement to the athlete or parent/guardian on account thereof. Athletes do not participate in the 2011 USBC Youth Open for reimbursement, compensation, or professional gain but solely to have the opportunity to win the National Championships and the appropriate prize or prizes involved. Any personal appearances or speaking engagements by the athlete will be done at no charge to the sponsoring organizations.

#### **TERMINATION/RELEASE CLAUSE**

To the Chief Executive Officer of the United States Bowling Congress: I/We, by our captain and agent, hereby make application to participate in the 2011 USBC Youth Open and tender the entry fees required therefore. We warrant that we are USBC Youth Members. We agree to abide by all tournament playing rules and regulations prescribed by USBC, including all provisions set forth on this form. We specifically agree for ourselves and any replacements chosen by us that if we are not eligible for participation and/or cannot bowl in the USBC Youth Open, then our prize, bowling, and expense fees shall be forfeited and all sums tendered by us as prize, bowling and expense fees may be retained by USBC as liquidated damages. These entrants whose names appear hereon or their authorized replacements hereby agree that the USBC, its officers and agents shall be liable only to the extent of returning entry fees, less expenses, if and when those entrants shall be prevented from bowling any event in the tournament through premature termination of the tournament, which may be brought about by war, national emergency or emergencies or causes relating there to resulting there from, fires, labor difficulties, terrorism or threats of terrorism, or other causes beyond the control of USBC. We further agree that USBC may use our names and likenesses (including video) for promotional purposes at no cost to me and with no fees being paid by us.

The entrants whose names appears on this application and/or authorized replacements hereby agrees that the USBC, and its officers and agents, shall not be liable for any injury resulting from participation in bowling in the USBC Youth Open, absent willful or gross negligence on the part of USBC.
