Tournament will be certified by USBC and is a scratch event. **2.** All USBC rules will apply unless otherwise noted. **3.** Each bowler will bowl 6 games across 12 lanes. **4.** Each bowler must be a current 2011-12 USBC member. **5.** Entry Fees - FOUR OPTIONS **OPTION 1** - \$49 - Includes entry (\$30 prize fund, \$19 expenses) **OPTION 2** - \$109 - Includes entry and a DV8 Advanced-Performance bowling ball (\$30 prize fund, \$79 expenses) **OPTION 3** - \$136 - Includes entry, and 2012-2013 USBC Youth Standard Membership and Junior Gold Membership dues, entry into Junior Gold qualifying event (\$30 prize fund, \$106 expenses) **OPTION 4** - \$196 - Includes entry, a DV8 Advanced-Performance bowling ball, and 2012-2013 USBC Youth Standard Membership and Junior Gold Membership dues, entry into Junior Gold qualifying event (\$30 prize fund, \$166 expenses) **6.** There will be two divisions - Boys and Girls **7.** Prize ratio will be at least 1 in 6 or major fraction thereof. **8.** Walk-in entries will be accepted subject to lane availability. **9.** Tournament Director reserves the right to make an interpretation and decision on any rule, discrepancy and/or conflict that might arise.
